 - (a) Roll Out for each of the States/Regions requested indicating the number of sties targeted by year 1, 2, 3, 4, 5 of the licenses.
 - (b) Evidence of technical competence to deploy the licenses. Including as the case may be relationship with Technical partners.
 - (c) Evidence of financial capacity to support the Roll Out target.
